

TERMS AND CONDITIONS

1. N.I.T and other conditions can be seen/discussed in the office of the Executive Engineer-II on any working day before quoting the tender.
2. Conditional tender or tenders without earnest money are liable to be rejected.
3. Earnest money shall be received in the form of Bank draft of any scheduled bank pledged in the favour of Registrar, Punjabi University Patiala.
4. The tender shall only be quoted on prescribe forms.
5. If there is holiday on the opening day of the tender, the tender shall be received and opened on the next working day at the same time and at the same place.
6. University reserves the right to reject the whole tender or delete any item of the tender without Assigning any reason and tenders shall have no right of any claim what so ever for the same on this account.
7. Tender form shall be issued to those Bidders who have the PAN, GST No. etc.
8. Firm shall give self attested Certificate that they have not been debarred or black Listed at any stage by Govt./Semi Govt. organization or any corporation at any stage.
9. Prices should be inclusive of all taxes and levies in INR.
10. Payment will be released after successful installation and commissioning of purchased item as per Punjabi University rules.
11. Supplied item must be branded and shall be amply supported on site warranty directly by OEM.
12. Purchased Item is to be made available/installed within two weeks from date of placing confirmed Purchase Order along with all the bills.
13. The rate quoted by the Bidders shall be inclusive of all the taxes i.e. GST or any other taxes levied by Central Govt. or State Government Authority or Local Bodies including their variations as notified by the Concerned Authority from time to time and of all the new taxes and levies that may be imposed. Firm will supply the material on quoted Rates which include F.O.R., Loading, Unloading, stacking at Punjabi University, Patiala. Nothing Extra shall be paid.
14. Conditional tender or tenders without earnest money are liable to be rejected.
15. In case of failure of supply of material as per ordered specifications, the University reserve the right to reject the supply order and can forfeit the earnest money deposited by the firm. In case of any dispute, the Jurisdiction will be Patiala Local Court (Punjab) only.
16. An agreement will have to be signed with the Registrar, Punjabi University Patiala within 7 days of issue of supply order.
